I have a deep understanding of the environment, locally, nationally and internationally, and the roles of community, governments and business, and have been an enthusiastic member of the Conservation Council since 2008, at times holding positions of Vice President and President.

I have science qualifications (BSc Hons, Marine Ecology; MSc, NRM) and extensive experience in policy and management in the public and private sectors, including sustainability, agriculture, environment, protected area management (marine and terrestrial), commercial fisheries, tourism, transport, waste management, water (and the MDB), energy,

climate change, urban planning, sport and event management, and governance in not-for-profit organisations.

A career highlight was establishing and delivering the Environment Program for the 2000 Sydney Olympic Games.

For 12 years, I was an honorary board member of the Banksia Environmental Foundation which promotes and celebrates environmental leadership.

I have a long record of support of conservation generally, and conservation within the urban framework

Originally as a co-opted member of the Conservation Council board from 2007, I performed the secretariat role for the Biodiversity Working Group until July 2021.

I acted as back-up Secretary of the Conservation Council for several years until my formal appointment as Secretary five years ago.

Over the last couple of years I have worked with Helen Oakey to streamline the Board's communications and make them more efficient and transparent and to make the role of Secretary more transferable.

Prior to that, as an ACT Government public servant, I helped develop the *ACT Land (Planning and Environment) Act 1993* following self-government and worked on the leasing of rural and national land in the ACT.

Then as inaugural manager of the ACT's Office of the Commissioner for the Environment for 13 years, I coordinated multiple investigations into the ACT Government's management of the environment; and coordinated and contributed to multiple State of the Environment reports for both the ACT and 18 local governments of the ACT Region.

I am keen to continue my commitment to both the environment of the ACT and to the Conservation Council. I have recently joined Friends of Grasslands and will take up the role of secretary FOG after their next AGM.

I'm an ecologist who became an interdisciplinary scientist. I've worked with stakeholders and policy makers on ways to understand and influence the direction and pace of change in social-ecological systems including the Murray Darling Basin, Western Australia, SE Queensland and southern Africa. My understanding of social-ecological change has been deepened by political activism.

I'm a member of ACT Greens, Stop Adani Canberra, 350.org Canberra and Extinction Rebellion. I provide practical support to School Strike for Climate.

Past employers are the CSIRO (Principal Research Scientist), the Universities of Canberra and East Anglia (UK), the International Livestock Centre for Africa, the UN Food and Agriculture Organisation, the Zambian National Parks and Wildlife Service, and British Voluntary Service Overseas. I'm a founder member and fellow of the Resilience Alliance <https://www.resalliance.org/>. I was an Honorary (retirement) Fellow at CSIRO before my fellowship was terminated for my public opposition to cuts to climate science and other public good research. I'm now an Honorary Associate Professor at ANU's Fenner School of Environment and Society where I work on adaptation to climate change and advise postgraduate students.

Leon will give Conservation Council member groups more opportunities to help their board to make better decisions. Board decisions will be constitutional. Member groups will gain ready access to their board's meeting agendas and minutes.

Leon was the only Conservation Council board member, from 2010 to 2016, to assert the board's right to have at least 48 hours to consider non-urgent matters. He invites Gordon McAllister, Helen Sims, Peter Ottesen, Rod Griffith, Ian Falconer and Glenys Patulny to join him in apologising for past breaches of Rule 19 of the constitution.

Leon has been President of the ACT branch of the Solar Energy Society, served on the Pedal Power Council, founded and chaired Living Streets Canberra, and been Convenor and Secretary of Climate Action Canberra. Leon has been Chair (3 terms) and Secretary (4 terms) of the North Canberra Community Council. In 2018 Leon took over from the previous chair. In the following year the Council allowed members to raise issues at all general meetings, kept records of all committee decisions, made committee minutes available to members, produced three years of audited financial reports, submitted three years of annual returns, and adopted a new constitution.

Jackson BALME - ACF COMMUNITY CANBERRA

I'm a fourth-year law student at the Australian National University. I'm nominating to ensure that young people are represented on the board. As we all know, climate change and biodiversity loss are the greatest intergenerational injustices ever inflicted. It is, therefore, imperative to ensure young people have a voice in all decisions. I will strive to be that voice and advocate for young people in all governance decision-making.

Furthermore, I believe that young people are an untapped resource. I have seen the power of students through my work with the Environmental Defenders Office and Greenlaw at the ANU. These organisations have worked collaboratively with students to produce extremely valuable work.

Furthermore, using my connections at the ANU, I established a team of 12 university students to conduct a major investigation with the Australian Conservation Foundation. The team investigated whether Australia's largest greenhouse gas emitters are credibly estimating their greenhouse gas emissions in their environmental impact statements. The team worked incredibly hard, and the research is being used to pursue climate litigation against coal mines who are breaching their environmental obligations. I will advocate for the Council to tap into this resource to ensure that we achieve our goals for 2022.
