



Fundraising

Working Groups

Transport Working Group expertly led by Warwick Cathro

Biodiversity Working Group expertly Chaired by Hugh Coppell, now chaired by Matt Whitting

Environmental Justice Working Group, with rotating chair

- All meet monthly with regular strong attendance and representation across Member Groups.
- Environmental Justice Working Group has embedded a range of policies and norms within the organisation.
- Transport Working Group has stopped meeting after developing election platform, but is now setting up again
- Rethinking purpose of each group
- Policy platforms developed for 2024.







Challenges

- Our organisation has a broad scope and many competing demands.
- Expectations from Government and community remains high.
- Constrained financial resources and staff capacity.
- Increased costs and financial pressures due to inflation, an increase in the award wage and super, rising insurance costs, complexity of work, business compliance, operational costs, financial accountability, management of risk, competitiveness in the ACT labour market, and reduced donations.
- The Conservation Council is currently facing serious financial pressures.
- There will be a short period in early 2025 with only two staff. Please be patient with us during this time.

Ngunungula/Bluetts Block

- Held a community forum in October 2023
- Bush Buds walk at the Block
- Continued to conduct pressure with MLAs and EPSDD across the year.
- Government decision to develop 'Stromlo Reach', which we opposed.
- ACT Government declared Blocks 402 and half of 12 will be established as a into nature reserve.
- More work to be done to place Block 403 into reserve, and to ensure strong maintenance of Bluetts.

Save Lawson Grasslands

Significant changes across the course of the year

- Undertook regular protests outside DHA office in latter half of 2023.
- Threatened Species Day Protest
- In January 2024, DHA obtained an approval to significantly reduce the area (in hectares) of grasslands they will destroy
- Still more work to be done
 - When the EIS is published, object to the fragmentation of Lawson Grasslands
 - Failing that, ensure strong buffer zones between residences and the intact grassland areas
 - Land to be transferred to ACT Government
 - ACT Government needs to declare it a nature reserve







Save Canberra Dragons

What has happened this year

- Recalling Canberra Grassland Earless Dragons were listed threatened (critically endangered) on 1 June 2023 ...
- Canberra Airport wants a 'Northern Road from Fairbairn north to Majura Road (see the diagram)
- The Council repeated its call, in Sept and Nov 23, for the Minister to refuse the road and thus protect Canberra Dragons
- Letters were clear, bisecting the place where the population lives at Canberra Airport would dramatically increase the species' extinction risk.
- The Department says they are waiting on Canberra Airport to propose a new option(s). The path is clear, stop the road.

 - To increase public and political awareness of the relationship between climate change and nature loss
- 4 successful walks held over the financial year, all booked out.



The Nature Conservation Act

- 1. Nature Conservation Act is the ACT's premier environmental legislation.
- 2. It is failing.
- 3. More species are being added to our endangered species list, while the Government continues to destroy ecosystems to expand our city.



What's the problem with The Nature Conservation Act?

The NC Act fails to protect, conserve, enhance biodiversity, because:

The Act focuses on individual species rather than landscapes, resulting in fragmentation of critical habitat.

Climate change is not considered as a key threat to our nature

The legislation lacks primacy over other legislation in nature reserves.

Significant powers are held by planning authorities, favouring development outcomes over nature. Enforcement and measures to promote compliance are insufficient, including a lack of clearly defined indicators for assessing the efficacy of conservation strategies.

Lack of legal requirements for measuring and reporting on biodiversity outcomes.



What we think needs to change

- Base new legislation on an ecosystem approach, to enable the ACT Government to implement an ACT-wide biodiversity network so all valuable areas - whether a national Park or on the roadside - are managed well.
- Key elements of the legislation are moved away from planning authorities to the Nature Conservation Act.
- List climate change as a key threat to nature.
- Recognise the authority of the region's First Nations peoples as stewards and include decision making powers in the ACT.
- Decision makers must refuse developments with unacceptable impacts on threatened species (or their habitat) and threatened ecological communities.

- Strengthen compliance mechanisms and actually do some enforcement, including higher penalties for dodgy developers who destroy our nature.
- **Give rangers powers** to enforce the Act in reserves.
- Make the Conservator of Flora and Fauna independent, with their powers widened and strengthened.
- Legislate a requirement for a regular review of measurable qualitative and quantitative targets with publicly available outcomes.





Our Campaign



- Raised the profile of the issue as a key ask for the ACT election 2024 - undertaking media, advocating with candidates, hosting candidates forum.
- Run a webinar in December 2024.
- Run a community event in early 2025
- Develop and run a petition calling for fixes to the Act
- Host briefings for key decision makers
- Develop case studies of how our current laws are failing, and highlight these in our social media, newsletter, website etc.
- Run a social media campaign.
- Undertake relevant submissions and encourage others to put in submissions calling for stronger laws.





Ngununggula/Bluetts Block and Western Edge





