| 7. | Appointment of Auditor for 2022-23 | |
| | This item was dealt with out of sequence, with Sarah explaining that Mr Greg Field's availability for 2022-23 had not been confirmed at the time of the AGM and that the Board would appoint an auditor as soon as possible. | |
| 8. | Election of members of the board, including office bearers: Before moving into the election process, the President introduced Peter Ottesen, a current Vice President of the Council and Convenor of the Board's Governance Sub-Committee. Peter was asked to respond to an email circulated by Leon Arundell claiming that 4 existing member organisations are now not eligible to be members because of changes to the constitution last year. | |
| | Peter Ottesen's response: Thank you for this opportunity to address this matter and to remove any doubt or confusion before we begin the election of a new board. | |
| | The short answer is that there is not, I repeat not, an eligibility problem. | |
| | There was a response from Marcus Hassall (board member and barrister) to the 4 member groups saying that this is not the case, and reassuring them that they continue to be members of the Council. | |
| | It is true that changes were made to the constitution to clarify member eligibility but most importantly, as is stated in the new constitution on page 29, and I quote <i>Amendments made to the membership provisions</i> on 18 November 2021 do not affect the validity of the appointment of members prior to the date the amendments took effect." | |
| | Mr Arundell has misread and misunderstood the constitution; if he had asked the Council for clarification - email or telephone - this would have been provided and he would not have needed to send an email to the 4 members raising uncertainty and possible confusion. | |
| | So in conclusion, all member organisations of the Council prior to 18 November 2021 are eligible to vote tonight. | |
| | Comments: Bill Gemmell thanked Peter for that clarification as the email had caused concern. Leon Arundell spoke in support of his action. | |

The President notified the meeting that Section 14b. of the Constitution determines that the ballot must be held in the way directed by the Board. On 13 October 2022 the Board agreed to the ballot process, which was subsequently implemented.

Everyone at the AGM had the opportunity to read the statements provided by nominees for all positions. All nominees for the contested positions took the opportunity to speak for 2 minutes.

The President advised that the Board had appointed David Southgate as the returning officer.

1. The President stood down and the Returning Officer took over as chair.

For the position of President no election was required - One nomination was received for the position of President, that is **Sarah Reid**. Having received no further nominations for the position of President the Returning Officer declared that **Sarah Reid** is duly elected President.

For the two positions of Vice President an election was required - three nominations for the positions of Vice President were received - Jenny Edwards, Rod Griffiths and Leon Arundell. As the number of nominations (3) exceeded the number of vacancies to be filled (2), a ballot was held in accordance with section 14e. of the Constitution.

Following the ballot, David Southgate declared that the following people have been elected to the positions of Vice President Jenny Edwards Rod Griffiths

3. For the position of Secretary one nomination was received - that was from **Kathy Ehmann.** Having received no further nominations for the position of Secretary, **Kathy Ehmann** was duly declared as Secretary.

4. For the positions of Ordinary Board Members, 8 nominations were received for the positions of Ordinary Board Members. Nominations were received from: Victoria Herbert, Warwick Cathro, Leon Arundell, Marcus Hassall, Correa Driscoll, Annika Reynolds, Kimberley Slapp, and Vivienne Pearce. As the number of nominations (8) exceeded the number of vacant positions to be filled (6), section 14e. of the Constitution required that a ballot be held.
Following the ballot, the returning officer declared that the following 5 people had been elected to the positions of Ordinary Board member:
