# Floating Sauna, Lake Burley Griffin

#### Introduction

The Conservation Council ACT Region appreciates the opportunity to provide comments to the National Capital Authority regarding floating saunas on Lake Burley Griffin.

The Council has no strong views on the construction or location of floating saunas per se.

However, the Council opposes the use of wood-burning fires on the structures.

The ACT Government has a clear policy and program to phase out wood-burning heaters.

While a traditional wood fire in a sauna would

"offer nostalgic charm and comfort, ... the smoke they emit is a direct source of pollution ..., a clear and present danger to the well-being of our community in urban and suburban areas, and a looming threat to our natural environment. Wood heaters are already prohibited in many new development areas". (media release by Minister Vassarotti<sup>1</sup>)

The ACT Commissioner for Sustainability and the Environment is quoted in the same media release, saying "there is no safe level of air pollution for human health. Wood heaters have no place in Canberra's all-electric, 100% renewable energy future."

The Council also objects to wood-burning heaters on the basis of the damage to native habitat and biodiversity from unregulated firewood collection and sales.

It would be inconsistent and hypocritical for any ACT authority to approve the use of wood-burning heaters for these saunas, especially in such a public installation, when new wood heaters are already banned in parts of Canberra.

Australian Sauna & Steam Rooms, for example, offers a variety of electric sauna heaters, perfectly effective and ambient for the purpose. This would be a simple substitute to allow the floating sauna to go ahead. The proponent will need to amend plans to show the power supply (perhaps rooftop solar and battery).

### Summary and Recommendations

The Conservation Council recommends that the wood heaters be replaced with electric heaters.
