# Walk the Border - Light wrap up

Sunday 25 November wrapped up our 2018 Walk the Border - Light!

We had a great start to the program with a walk from Woods Lane to Hume. In fine weather, the walkers took in lots of history and some big views.

It was a mild and sunny day for the second walk. Participants got to experience the views and history of the zig zag section of the ACT's border in North Mulligans Flat Nature Reserve. A big highlight was the sighting of a small number of golden sun moths, a nationally endangered moth species found only in grasslands.

The third walk brought together a big group of 32 walkers, who explored ACT's far eastern point. Brooks Hill Reserve has some magic trees including the CT blazed tree at the most easterly point of the ACT and some great views.



The final walk treated walkers to sightings of classic ACT NSW border markers and some spectacular views towards the south of the ACT. Very poignant was the memorial to the team of 200 workers who helped construct the Queanbeyan to Cooma railway in the late 1800's. It was also good to meet the participants of the Save Kosci protest walk who are doing a great job highlighting the threats that feral horses pose to Australia's alpine regions.

All of the walks have highlighted the history of the establishment of the ACT and many varied environments it contains. Thanks to all the walkers for their good company.

# School Strike for Climate Action a great success!

On Wednesday 28 November, we joined young people from across Canberra, who walked out of school to call for real climate action to protect our future.

Students protesting climate change arrived in Canberra after the prime minister told them to be less activist and go back to school. Hundreds of students lined up outside Parliament House on Wednesday wanting to speak to Scott Morrison and government ministers about taking emergency action against climate change. The students waited in the rain outside parliament and met with Labor, Greens and crossbench MPs, including the federal Greens leader, Richard Di Natale.



This youth activism brings about a strong sense of hope:

we are building a powerful movement that will keep pushing our politicians until they do what it takes to stop the climate crisis and protect our futures. It represents the beginning of a new age of activism from Australia's youth who are sick of not having their voices heard.

# Transport emissions the next challenge in the ACT

Reducing emissions from transport is the next big climate change challenge in the ACT. We already have targets to achieve 100% renewable electricity by 2020 and zero net emissions by 2045.

Transport is the second biggest source of emissions in the ACT after electricity (**see picture, right**). Transport emissions will be the largest source post-2020, when the ACT achieves its 100% renewable electricity target. This makes it the next frontier in the government's efforts to reduce the ACT's impact on climate change.

This year, Shane Rattenbury MLA released an Action Plan to accelerate the adoption of zero emissions vehicles in the ACT that will take us through to 2021.

It is clear that transport is, and will become increasingly so, a critical focus for reducing emissions in the ACT. In this Canberra Time article, the transitioning ACT Climate Change Council indicated it will turn its focus to the transport sector to ensure we meet our zero net emissions targets.

We are also looking forward to seeing the draft Transport Strategy early next year, in particular how it will tackle emissions.

#### Phase out of gas

If we are going to achieve zero net emissions by 2045 at some stage we have to talk about a strategy to reduce our emissions from gas to zero. In 2020, gas will be 21% of our greenhouse gas emissions compared with 10% in 2012.

The most important thing though is that a clear timetable to phase out gas is put in place and "new" gas is actively discouraged as a matter of urgency. We think it seems reasonable that a phase-out in ten years by 2028 should be possible. We are hoping the next Zero Net Emissions Action plan will have a clear pathway for phasing out gas. We have flagged this with Minister Rattenbury who has confirmed that the strategy is still being considered within government and is expected to be released in early 2019.

#### Playing with gas in Ginninderry

The developers of Ginninderry wanted to have a development without piped natural gas. However, gas-

free development (follow link and look at question on gas) conflicts with ACT Territory Plan, which requires that gas is provided to all residential blocks (Territory Plan, Estate Development Code, p14).

We want an overall ongoing variation to the Territory Plan to remove the mandatory requirement - so that we don't have to do a variation for each new suburb and that we can genuinely make the transition to zero net greenhouse gas emissions.

The Conservation Council has been engaged on this issue for some time and we conducted a very interesting Environment Exchange in 2017 "Beyond Gas".

# Cat containment update

The Conservation Council's position on cat containment is that all of Canberra should be covered by cat containment laws by 2025.

Recently we heard about Canberra's growing stray cat problem. The Conservation Council commented on the issue, noting the environmental consequences of letting cats roam without controls.


Our position has previously received public support from the Commonwealth's former threatened species commissioner, Gregory Andrews. The commissioner pointed to the science, which shows that domestics cats are killing 61 million birds and 53 millions reptiles every year.



We are expecting a community consultation paper on broadening cat containment laws from the ACT Government in coming months. We will stay informed on this timeline — let us know if you have any other thoughts on the issue.




### Waste-to-energy consultation period extended

The consultation period on ACT's waste-to-energy policy now closes 14 December 2018. The ACT government is still seeking community input on waste-to-energy policy to clearly outline the Territory's position on energy recovery as a waste management solution and provide a framework for assessing any future waste-to-energy proposals.

Some of the steps you can take include:

We welcome the new ACT Planning Strategy released by Minister Gentleman's office yesterday. It is finally biting the bullet on greenfield developments.

The new Planning Strategy rules out urban development in Central Molonglo, West Greenway and West Murrimbidgee - all of which we have been vocal about as not being suitable for urban development due to their ecological values. This reflects the good work of the Conservation Council a decade ago that led to a variation to the Territory Plan to remove Central Molonglo from being considered a possible urban development area in perpetuity.

We also welcome the focus on urban infill. It is great to see that the trend for ongoing urban greenfield sprawl may be coming to a sensible end in the ACT.
